## Springfield Lasers World TeamTennis Matches

Tickets are on sale now for seven home World TeamTennis matches featuring the 2009 Show-Me-State Cup and WTT Western Conference Champion Springfield Lasers. Home matches are scheduled to start at 7:05 PM on July 5, 7, 11, 16, 17 19, and 20, with gates opening at 5:30 PM. On Monday, July 5, the season opener, watch the Lasers take on former WTA number one, Lindsey Davenport, and the St. Louis Aces. On Saturday, July 17, watch the Lasers battle former WTA number one, Martina Hingis, and the New York Buzz. Individual ticket prices for non-marquee matches are \$10 for Grandstand and \$20 for Box Seats or \$15 and \$30 for the Davenport and Hingis matches. ## World TeamTennis Tournament

After watching the Springfield Lasers play, register your own team for a World TeamTennis Tournament. The tourney will be held at the end of the WTT professional league season, July 30 – August 1, at the Cooper Tennis Complex. Teams consist of a minimum of 2 guys and 2 gals or a maximum of 8 players. Each round will consist of men's and women's singles, doubles, and mixed doubles, and is won by the team with the most overall games at the end of mixed doubles. All WTT rules and format of play will be used including no-ad scoring, let serves played, overtime and super tiebreakers. For only \$20 per player, teams are guaranteed 2 matches and one t-shirt per player. Play is available in NTRP levels 3.5, 4.0 & 4.5. Winning teams can advance to National Qualifying events in the next 12 months.
